BE IT REMEMBERED THAT, the Monthly Session of the Jefferson County Board of Commissioners began and was held in and for the aforementioned State and County on the 18<sup>th</sup> day of September 2017 A.D. at 6:30 P.M., at the Jefferson County Courthouse in Dandridge, Tennessee. Present and Presiding were Chairman Jimmy Carmichael; County Clerk Frank Herndon; and the following County Commissioners answering to Roll Call Docket Book 4 Page 17 to-wit: Katy Huffaker, Todd Kesterson, Steve Douglas, David Gaut, Randy Baxley, Donnie Tabor, Rita Musick, John McGraw, Russell Turner, Tim Seals, Robert Blevins, Ralph "Gene" Eslinger, Randy Bales, John Neal Scarlett, Terry Dockery, Robert Tucker, David Seal, Bob Beeler, and Barbara Sheets. Twenty (20) members were present one (1) was absent: Sammy Solomon.

The Meeting was called to order by Chairman Jimmy Carmichael. An invocation was given by Chaplain Donnie Tabor, followed by the Pledge of Allegiance led by Chairman Jimmy Carmichael.

#### NOMINATION & ELECTION OF COUNTY COMMISSION OFFICERS

- CHAIRMAN PRO TEMPORE Commissioner Blevins nominated Commissioner Kesterson, Commissioner Beeler moved to cease nominations, with no objections, Commissioner Kesterson was elected by acclimation.
- PARLIAMENTARIAN Commissioner Huffaker nominated Commissioner Scarlett, Commissioner Beeler nominated Commissioner Gaut, hearing no further nominations from the floor, a Roll Call vote was taken and Commissioner Gaut was elected Parliamentarian.

Commissioner McGraw, hearing no further nominations from the floor, a Roll Call vote was taken that ended in a tie 10-10. Commissioner McGraw requested to withdraw his name from consideration and with that Commissioner Tabor was elected by acclimation.

#### **APPROVAL & CORRECTIONS OF THE AGENDA:**

County Clerk Herndon mentioned that a report from the Jefferson County Rescue Squad was added to items of information. With no opposition from the floor, the agenda was **approved** as presented with this addition.

#### **APPROVAL OF THE MINUTES:**

Commissioner McGraw moved to approve the minutes of the Regular Quarterly Session, July 24, 2017 and the Jefferson County Beer Board July 24, 2017. Commissioner Seals seconded the motion and the minutes were approved with no objections voiced. Approved 10/16/2017

### **APPEARANCE OF CITIZENS:**

- Matthew N. Bobick District 8: As a resident of the Parrotts Chapel Community, Mr. Bobick spoke in favor of Jefferson County ceding the Parrots Chapel Community to Sevier County, stating Sevier County schools would not accept Jefferson County students.
- Steve McSmith District 8: Spoke in favor of the Parrotts Chapel Community ceding to Sevier County. Mr. McSmith thanked commissioners who were involved in the fact-finding process.
- 3. Tina Bobick District 8: Requested that County Commission visit the Parrotts Chapel Community and respect conversations from community members. Ms. Bobick offered commissioners to come and spend a week in her home travelling daily to JCHS.
- **4.** Charles Fleming District 8: Spoke to the hardship of Flat Creek residents' due to their isolation from the center of Jefferson County.
- 5. Missy Graves District 8: Request consideration of Jefferson County ceding the Parrotts Chapel Community to Sevier County from the Gator Point Community.
- **6.** Stanley Kaliszak District 8: States that he only pays taxes, registers vehicles, and votes in Jefferson County, all other business he conducts through Sevier County stating except for these three items, he considers himself a Sevier County resident.
- 7. Katherine Noyes District 10: Spoke to clarify her relationship with the humane society, she states that she was a founding member of the Humane Society, then stepped away for 15 years before returning as a citizen member of the ACOC.
- 8. Hannelore Miller District 8: No response when called.

- A. County Mayor, Alan Palmieri
  - 1. Mayor Palmieri spoke to the fact that the City of Morristown provided matching funds for two different grants to pay for the road improvements in the ETPC.
  - 2. Mayor Palmieri spoke to the reasons Jefferson County has been labeled anti-economic development.
  - Mayor Palmieri stated that the Mayor's office does not work for County Commission, and he would not be dictated in what to do about researching the idea of Jefferson County ceding the Parrotts Chapel Community to Sevier County. He quoted TCA 5-2-104 that sets guidelines for changing county boundary lines.

Commissioner Musick offered a motion to suspend the rules to add a vote in New Business to give consent to the City of Morristown to continue with their road project in the Allen Road area of District 3. Commissioner Bales provided a second and after a vote by show of hands 14-6 the motion **carried** and the rules were suspended and the item was added.

Commissioner McGraw offered a motion to suspend the rules to add a preliminary vote in New Business to proceed with a study on a cost analysis of the services provided to the Parrotts Chapel Community and the cost of ceding the Parrotts Chapel Community to Sevier County. Commissioner Seals provided a second and after a vote by show of hands 15-5 the motion **carried** and the rules were suspended and the item was added.

B. Sheriff, G.W. "Bud" McCoig

Sheriff McCoig stated that the E-911 center received two complaints over the rodeo in White Pine, he was personally unaware of the complaints when he spoke at the work session last week.

C. Highway Superintendent Charles Tipton

Progress Parkway Extension in East Tennessee Progress Center (ETPC) Industrial Park for Howard Allen Road Reroute. Mr. Tipton told the commission that the City of Morristown was simply making Jefferson County aware of the project out of courtesy and he wished that the Commission would respect the decision that the Highway Commission had made.

The Conservation Board has completed land transfers with Safespace and is thankful to them for working with the board for this development. The board is working with JCEMS and JCRS on solutions to parking issues. The board is working with the Town of Dandridge on the incorporation of a dog park that they are looking at pursuing.

C. Facilities Committee Chairman, Jimmy Carmichael

The Facilities Committee met and has been in contact with Kimley Horne of Nashville to review the ADA compliance of County Buildings, it was reported that this was the only company that answered the RFP in a timely fashion. The Facilities Committee has also received a report from Michael Phagan on the collapse of building 8 at JCHS which they have forwarded on to the commission for review.

 The Finance Committee is working on preparing for the sale of some county owned land parcels that ownership has reverted to Jefferson County because no bid was placed on the property at an auction held by Chancery Court for back taxes. More information is to come on this item.
