Sixteen (16) members were present five (5) were absent: Katy Huffaker, Randy Baxley, Rita Musick, John McGraw, Russell Turner.

The Meeting was called to order by Chairman Robert Tucker. An invocation was given by Chaplain Donnie Tabor, followed by the Pledge of Allegiance led by Commissioner David Seal.

LEGAL UPDATE

Clinton Little with the law office of Eric G. Foust presented to answer questions regarding the lawsuit with Wilmoth Family Properties DBA Cedar Pond Farms. Suit was filed May 5, 2017 on behalf of the planning commission and a temporary injunction was requested. The suit was filed in Jefferson County Chancery Court, Chancellor Forgety recused himself from the case, and they are currently waiting for a new judge to be assigned.

APPROVAL OF THE MINUTES:
