#### INTRODUCTION

#### A. Goal

With the desire to become more accommodating to customers and employees with disabilities, to be in compliance with the laws and regulations of the community and state and to be qualified to apply for certain state and federal grants, Jefferson County hired Partners Development and The Architecture Collaborative to perform an assessment of their facilities in terms of compliance with the American Disabilities Act.

The goal was to assess existing facilities to determine areas that failed to meet the 2010 ADA Standards for Accessible Design, to describe in general the solution for correcting any deficiencies, and to provide an opinion of the probable cost to implement the improvements to correct these situations. This information can then be used by the County to develop a long-term transition plan to address these issues.

#### B. Process

To accomplish this task, the process followed consisted of six distinct elements, as follows:

- Collection of documentation: plans and site images
- Public input
- On-site inspection and observation
- Cataloging of deficiencies
- Suggested corrective measure
- Opinion of probable cost

#### 1) Collection of Documentation

The team relied on Jefferson County to provide drawings of the facilities. Drawings were limited in availability and varied from facility to facility. Due to the lack of architectural floor plans for most of the buildings no diagrams are included to help depict locations of deficiencies.

#### 2) Public Input

In conjunction with Jefferson County staff, a public meeting was conducted on April 29, 2019 from 1PM-2PM at the Jefferson County Courthouse to discuss and receive input regarding Jefferson County's ADA Transition Plan. For reference, you may find the public meeting notice, attendee list for the meeting, and ADA Grievance Procedure in Appendix A at the end of this document.

The public has provided feedback to the ADA Coordinator regarding several facilities. The Courthouse receives the most complaints with the majority involving the fact that the door opens inward instead of outward, poor signage, and various fail/trip hazards. The public has yielded complaints regarding the Health Department and the Clerk's Office and the various trip hazards at each facility. In addition, the parking lot at the Agriculture Extension office routinely receives comments regarding its lack inaccessible restrooms, poorly marked/inadequate parking lot

#### 3) On-site Inspection and Observation

Site visits were made for each of the facilities listed by a licensed architect and staff. Visits included a walking inspection of the site and a tour of the building. Visual inspections were made to check for compliance with:

• 2010 American Disabilities Standards (ADA) for Accessible Design https://www.ADA.gov/regs2010/2010ADAStandards/2010ADAStandards.pdf

• ANSI 117.1 - Accessible and Usable Buildings and Facilities

Observations did not include observations for violations of other codes, including:

- NFPA 101 Life Safety Code
- International Code Council (ICC) suite of building codes

Inspections did not include structural, mechanical or electrical engineers and no evaluations were made of structural, mechanical, electrical systems or any other building systems. Hazardous material surveys were not performed as part of this scope.

The following facilities were assessed: [Exhibit A]

#### 4) Cataloging of Deficiencies

ADA Checklist developed by ADA National Network (ADAchecklist.org) was utilized for cataloging deficiencies. Deficiencies were placed in four priorities, in accordance with the following outline:

- Priority 1: Approach & Entrance
- Priority 2: Access to Goods & Services
- Priority 3: Toilets
- Priority 4: Additional Access

#### 5) Suggested Corrective Measures

There are a number of corrective measures suggested. However, a design professional should be consulted to provide definitive solutions based on a complete inspection and understanding of as-built information, building systems, and potential additional programming requirements.

#### 6) Cost Analysis

An opinion of probable cost was applied to each of the tasks in order to provide an indication or ballpark indication of the degree of cost impact. It is important to note that costs may vary considerably depending on multiple variables, including:

• whether tasks are handled internally by maintenance staff or bid to private general contractors.

how tasks are grouped in packages to be performed

• the limits of the work, whether the bare minimum to correct the deficiency is performed or whether the scope is expanded to include adjacent, related work.

Design fees or other management costs are not included.

#### 7) Funding and Implementation

In discussion with Jefferson County staff regarding funding the identified ADA improvements, the bulk of the implementation strategy will be addressed by targeting specific projects within the budget each year with the work being done by a general contractor. In an effort to facilitate implementation, staff will work to group as many similar projects together as possible. Lastly, staff will research grant opportunities and identify opportunities to address the work through planned future capital projects.
