BE IT REMEMBERED THAT, the Monthly Session of the Jefferson County Board of Commissioners began and was held in and for the aforementioned State and County on the 18<sup>th</sup> day of November 2019 A.D. at 6:30 P.M., at the Jefferson County Courthouse in Dandridge, Tennessee. Present and Presiding were Chairman, Mayor Mark Potts; County Clerk Frank Herndon; and the following County Commissioners answering to Roll Call Docket Book 4 Page 72 to-wit: Katy Huffaker, Todd Kesterson, Steve Douglas, Jimmy Dale Patterson, Paul Lowe, Michael Phagan, Glen Warren, Greg Byrd, Edna Langley, Tim Seals, Sammy Solomon, Robert Blevins, Randy Bales, John Neal Scarlett, Ronny Coleman, Terry Dockery, Jimmy Carmichael, Anthony "A.J." Walker, Marcus Reed, and Hilda "Heidi" Thomas. Twenty (20) members were present, one (1) was absent: Ralph "Gene" Eslinger.

The Meeting was called to order by Chairman Potts. An invocation was given by Chaplain Steve Douglas, Sheriff Jeff Coffey led the Pledge of Allegiance. Mayor Potts recognized all veterans who were present at the meeting.

## APPROVAL & CORRECTIONS OF THE AGENDA:

Commissioner Carmichael moved to approve the agenda as presented, a second was provided by Commissioner Solomon, a Roll Call vote was taken, and the agenda was **approved** 20-0 (in favor: all present).

## APPEARANCE OF CITIZENS:

Mackey Wilson – District 6: Spoke to Commissioners expressing his interest in the vacant Constable position in his district.

### APPROVAL OF THE MINUTES:

Commissioner Solomon moved to approve the minutes of the Jefferson County Board of Commissioners October 21, 2019 Regular Monthly Session. Commissioner Seals seconded the motion and the minutes were **approved** with a Roll Call vote 20-0 (in favor: all present).

# REPORTS FROM ELECTED OFFICIALS, DEPARTMENT HEADS, AND OTHER OFFICIALS:

- A. County Mayor, Mark Potts Mayoral Appointments:
  Regional Planning Commission/Board of Zoning Appeals Appointment Commissioner Paul Lowe Continue the
  Term of Randy Baxley September 2019 September 2023. The Mayoral appointment was moved for
  confirmation by Commissioner Coleman, seconded by Commissioner Phagan, with a Roll Call vote taken 18-0-2
  (in favor: Huffaker, Kesterson, Douglas, Patterson, Warren, Phagan, Byrd, Langley, Solomon, Blevins, Bales,
  Scarlett, Coleman, Dockery, Carmichael, Walker, Reed, and Thomas; Commissioners Lowe and Seals abstained)
  the appointment was confirmed.
- B. Commissioner Huffaker: Commissioner Huffaker presented a copy of a petition for entry into the minutes from Jefferson County residents requesting that Dollar General build their upgraded brick store design model at the Exit 424 Dandridge/White Pine site location.
- C. Director of Schools, Dr. Shane Johnston: Dr. Johnston addressed Commissioners as to several rumors he is trying to quell and would appreciate the Commissions assistance if they are questioned:
  - 1. Heat repairs are in the works at Dandridge Elementary and White Pine Schools. He stated that while the heating systems were not up to par, no room was occupied by a child with a temperature less than 65 degrees.
  - 2. Dr. Johnston stated that while School Employees and Board Members did attend a recent leadership conference that they attend each year, it did not cost the quoted \$50,000 that has been rumored.
  - 3. Dr. Johnston stated that a recent needs assessment has been completed, however it has not been prioritized by School Board Members and they are not prepared to present a capital improvement plan.
  - 4. Dr. Johnston stated that he has heard the rumor that he is seeking employment elsewhere, however this rumor is false. He states he feels he is where the Lord would have him be at this time in his life.
  - 5. Dr. Johnston stated that due to either a lack of compaction at the tennis courts or soil failure after the prior courts were installed, there was an overage of \$42,653 in that phase of the project. He stated at the current time, there is enough contingency to complete the project, however he fears that as the Softball Complex phase of the project is completed, if there is an unexpected overage there will not be enough contingency to complete that phase of the project and due to the upcoming start of the softball season, the project would need to be completed before Commission is scheduled to meet again. He stated that due to the tennis courts being a shared community park and the school system using a grant to upgrade the lighting that was outside the scope of the project he asked that the Commission consider allocating funds to cover the overage if needed for the completion of the project. Commissioner Phagan made a motion to suspend the rules to address the request to fund the tennis court repairs. Commissioner Huffaker provided a second. A Roll Call vote was taken, the motion carried 19-1 and the rules were suspended (in favor: Huffaker, Kesterson, Patterson, Warren, Lowe, Phagan, Byrd, Langley, Seals, Solomon, Blevins, Bales, Scarlett, Coleman, Dockery, Carmichael, Walker, Reed, and Thomas). Commissioner Phagan made a motion to allow the Director of Finance to allow \$42,653 from the General Fund to be used should they be needed to cover the cost of the tennis court repair to be the last dollars spent. Commissioner Langley provided a second. Commissioner Kesterson amended the motion to direct that the funds come from the Hospital Fund, Commissioner Lowe provided a second. After a lengthy discussion, Commissioner Bales called for the question, with no objection to the call, a Roll Call vote was taken, and the amendment failed 5-15 (in favor: Kesterson, Lowe, Phagan, Langley, and Dockery). A Roll Call vote was taken on the original motion and it carried 13-7 (in favor: Huffaker, Warren, Lowe, Phagan, Langley, Seals, Blevins, Bales, Scarlett, Carmichael, Walker, Reed, and Thomas).
- D. Solid Waste Director, David Gaut Cell Construction, Closure, and Permitting report presented and filed.

  - 1. Jefferson County Constable Vacant Seat District 6: Mayor Potts announced the need to fill a vacancy for the office of Constable of the 6<sup>th</sup> District due to the resignation of James W. "Jim" Baldwin. Mayor Potts requested for the names of those who have filed the required Affidavit for Election to the Office of Constable be announced to Commission. County Clerk Frank Herndon announced the names of Mackey E. Wilson, Dusty Fisher, and Brian Millington. Mayor Potts opened the floor for nominations, Commissioner Blevins nominated Mackey Wilson, Commissioner Walker nominated Brian Millington. Hearing no further nominations, Commissioner Scarlett moved that nominations cease, Commissioner Byrd provided a second. Hearing no objections, nominations were **closed**. A Roll Call vote was taken Millington 6 Wilson 13, and Mackey E. Wilson was **appointed** to the Office of Constable for the 6<sup>th</sup> District to complete the term of James W. "Jim" Baldwin.

- 3. 2020 Jefferson County Commission Regular Session Schedule: A motion to approve the schedule as presented was provided by Commissioner Seals, seconded by Commissioner Coleman. A Roll Call vote was taken, and the schedule was **approved** 20-0 (in favor: all present).
