STATUTORY COMMITTEES – Committees, commissions, or boards created and mandated pursuant to the Tennessee Code Annotated.

STANDING COMMITTEES – Committees, commissions, or boards created by the Jefferson County Commission to perform a permanent, ongoing function that is vital to the operations of the County Commission. Standing Committees assimilate information in their area and report to County Commission at each regular meeting. Standing committees may be assigned sub-committees, special or ad hoc committees, and mandatory committees, and may call upon such committees for specific reports if deemed necessary.

SUB-COMMITTEES – Committees, commissions, or boards created by the Jefferson County Commission to perform either a temporary or a permanent ongoing function. Sub-committees are subordinate to and report to the Standing Committee under which the committee was created.

SPECIAL (AD HOC) COMMITTEES – Committees created by the Jefferson County Commission to perform a single purpose and then dissolve when the task is completed.

NOTES: County Commission took action on the following committees on the dates indicated

Elder Tax Relief (Ad Hoc Committee) – Established by Resolution 2011-29, June 20, 2011. Committee expired when task was completed.

Facilities Committee (Standing Committee) – Established by Resolution 2007-46, July 16, 2007. County Commission voted to remove the committee on October 18, 2010, and voted to Reinstated the committee by Resolution 2011-51, November 21, 2011.

Long-Range Planning Committee (Standing Committee) – Established by Resolution 2007-46, July 16, 2007. County Commission voted to remove the committee on October 18, 2010.

Quality Control Oversight Committee (JCHS, Bldg 8) (Ad Hoc Committee) – Established by County Commission on December 30, 2014. Committee expired on February 2, 2016 when task was completed.
