Replacement of the bridge on Carmichael Road over Long Creek.

All official notifications, addenda, and other Bidding Documents will be offered only through the designated web link. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated web link.

Bidders must be licensed as a Contractor in the State of Tennessee. Bids must be accompanied by a bid guarantee as specified in the Instructions to Bidders.

A Prime Contractor must have current prequalification status with the Tennessee Department of Transportation, and must be licensed with the Tennessee Department of Commerce and Insurance, in accordance with TCA 62-06-119, before bidding documents will be furnished.

Requests for information are due no later than **Friday, August 21, 2026**, by 5:00 PM ET. A final addendum, if needed, will be issued no later than **Monday, August 24, 2026**, 5:00 PM ET.
